

DISCLOSURE ON VIDEO SURVEILLANCE Aspects of Privacy for Passenger Protection

Premise:

Under the current privacy legislation (European Regulation 2016/679 "GDPR" Article 13, Provision of the Video Surveillance Authority Article 3.1 of 8 April 2010 as well as Legislative Decree No. 196/03 and subsequent changes and additions) the following information regarding the processing of personal data that is collected through video surveillance present at Catania Airport is provided. This information is to be integrated into the content of the simplified disclosure, which is rendered in accordance with and for the effects of the above-mentioned articles in order to provide you with the information relating to video surveillance systems, their use and your rights.

1. Data Controller and Data Protection Manager

S.A.C. S.p.A. wishes to inform you that a video surveillance system has been installed at the airport in accordance with the provisions of the EU Regulation of the European Parliament and Council 679/2016 and according to the indications, authorizations, notifications and communications provided by the Data Protection Authority (e.g. 8 April 2010 and further amendments).

The Data Controller, that is, the person responsible for the decisions regarding the purpose, modality and security of personal data, is S.A.C. – Società Aeroporto Catania S.p.A., based in Catania, Aeroporto Fontanarossa.

2. Person in charge of the protection of personal data

The Data Protection Officer, also known as DPO, monitors compliance with personal data regulations and cooperates with the supervisory authority (the Personal Data Protection Authority). Our personal data protection manager's email address is: <u>dpo@aeroporto.catania.it</u>.

3. Simplified information disclosure Article 3.1 Video Surveillance Authority

Video surveillance systems persist in areas that are appropriately signposted, in accordance with Article 3.1 of the above-mentioned Video Surveillance Provision, and clearly visible in all conditions of environmental lighting, where the aims pursued are also referred to.

These signs are placed before the cameras range or in the immediate vicinity.

4. Purpose of treatment

The data is processed for the following purposes:

- <u>Order and Public Safety</u> with particular reference to the type of place and in compliance with the airport security provisions contained in European (EU REG 1998/2015) and national (National Security Programme for Civil Aviation and. 2016) legislation;
- <u>Protection of Property</u> with particular reference to the protection of State-owned property and equipment, granted under contract authorization to SAC S.p.A., which will have to be returned at the end of the same;
- Detection, prevention and control of infringements carried out by public subjects in the context of the powers assigned to them by law, with particular reference to the public activities carried out by the airport operator under legal provisions also in the area of airport safety for the safety of passengers, operators and aircraft and vehicle traffic;
- <u>Evidence acquisition</u>. The need to ensure, in particular, a high level of protection of the fundamental rights and freedoms in relation to the processing of personal data allows for the possibility of using

video surveillance systems, provided that this does not lead to unjustified interference into the fundamental rights and freedoms of those concerned.

As resulting from the aforementioned notices, the recorded images are on digital media and stored for a period of no more than 7 (seven) days and can also be used by the Police Forces, who have the right to access the system, by the Judicial Authority, who can request permission to extract footage, or upon request by individuals who have the power to obtain it in accordance with the law, or by S.A.C. S.p.A. itself where appropriate.

5. Recipients and categories of processed data

The video surveillance system is duplicated at the Border Police for the performance of its institutional tasks (see paragraph 3.1.3 of the cit. Video Surveillance Authority's provision).

The data collected is processed exclusively by authorized personnel or designated treatment officers or by the police. The data collected through these systems is, however, processed by S.A.C. S.p.A. as the Controller, in accordance with the law by means of computer and telematic tools, and with a reasoning that is closely related to the stated purposes, in order to ensure safety and confidentiality and is not transmitted to persons other than those mentioned in the previous article or based outside the EU.

6. Storage time of personal data and criteria

The personal data being processed consists of images recorded on the video surveillance system that are stored by the same on digital media for a period of no more than 7 (seven) days, after which they are automatically deleted (see paragraph 3.3.1. letter c – Video Surveillance Authority's provision).

In special cases, in accordance with the law, footage can be extracted and stored for a longer period of time. In that case, a formal act justifying this is drawn up.

7. The rights of the person concerned

Regulation Articles 15-22 GDPR gives those concerned the opportunity, in accordance with the technical specifications of the system, to exercise specific rights. The person concerned can obtain processing access, adjustment, cancellation, or limitation from the Data Controller. You also have the right to object to the processing by addressing a request to the Data Protection Officer (DPO) whose contact details are indicated above in point 2. Any further explanation you might require regarding your rights and any requests you might have can be submitted in writing, accompanied by a valid ID document, to S.A.C. - Società Aeroporto Catania S.p.A., based in Catania, Aeroporto Fontanarossa, or to the e-mail address above.

These rights can be exercised within the limits set out in Article 3.5 of the Video Surveillance Authority. In particular, the right to update, rectify or integrate the recorded images is not in practice exercisable in view of the intrinsic nature of the data collected, as these are images collected in real time concerning an objective fact.
